

- Low Severity Issues
 - 1. Rounding error

Issue:

 Take fee calculations uses division first. In Solidity we don't have floating points, but instead we get rounding errors.

Recommendation:

Do division after multiplication.

2. Out of gas

Issue:

• The function manualSync() and setAutomatedMarketMakerPair() uses the loop to iterate through _makerPairs list. Function will be aborted with OUT_OF_GAS exception if there will be a long list.

Recommendation:

Be careful about array length.



Owner privileges (In the period when the owner is not renounced)

- Pauser can pause/unpause the contract.
- Admin role can add/remove market pairs addresses.
- Admin role can change rebase params.
- Admin role can enable/disable trading.
- Admin role can exclude from the fee.
- Admin role can change marketingAndDevAddress.
- Admin role can change fees.
- Admin role can withdraw contract ERC20 tokens.
- Admin role can manually change nextRebase value.

Conclusion

Smart contracts contain low severity issues! Liquidity pair contract's security is not checked due to out of scope. The further transfers and operations with the funds raise are not related to this particular contract.
